विकीलीक्सने गुरुवारी काही माहिती प्रकाशित केली. या माहितीत असे काही दावे केलेत की त्यात जरा जरी तथ्य असेल तर भारत सरकार आणि गुप्तचर यंत्रणेचे धाबे दणाणतील. या माहितीनुसार, अमेरिकेची गुप्तचर संस्था सीआयए सायबर हेरगिरीसाठी एक असं तंत्र वापरतेय ज्यामुळे कदाचित आधार कार्डाचा सगळा डेटा त्यांना मिळाला आहे. मात्र अधिकृत सूत्रांनी हा दावा फेटाळून लावला आहे.

विकीलीक्सच्या अहवालानुसार, अमेरिकन कंपनी क्रॉस मॅच टेक्नॉलॉजीने सायबर हेरगिरीसाठी हे तंत्र विसकित केलं आहे. हीच कंपनी आधारची नियामक संस्था युनिक आयडेंटिफिकेशन ऑथोरिटी ऑफ इंडियासाठी बायोमेट्रिक तंत्रज्ञान उपलब्ध करून देते. याच कारणामुळे कदाचित विकीलीक्सच्या दाव्यात तथ्य असू शकेल. विकीलीक्सने शुक्रवारी एक लेख ट्विट केला आहे. यात क्रॉस मॅचचा भारतातील पार्टनर स्मार्ट आयडेंटिटी प्रा. लि. चा उल्लेख आहे. या कंपनीने आधार डेटाबेसमध्ये १२ लाख भारतीय नागरिकांचा समावेश केला आहे. 'सीआयएच्या हेरांनी भारताच्या राष्ट्रीय ओळखपत्राचा डेटाबेस चोरला आहे का?' असं ट्विट विकीलीक्सने केलं आहे. याविषयी अधिकृत सूत्रांशी संपर्क साधला असता त्यांनी सांगितले की ही माहिती 'लिक' झालेली नसून तो एका वेबसाइटवरचा अहवाल आहे. क्रॉस मॅच बायोमेट्रिक ही कंपनी डेटा साठवणाऱ्या डिव्हाईसची जागतिक पुरवठादार कंपनी आहे. सर्व माहिती एन्क्रिप्टेड स्वरूपात आधारच्या सर्व्हरवर साठवली जात असल्याने ती एकत्रितपणे कंपनी किंवा अन्य कोणाहीपर्यंत पोहोचू शकत नाही. त्यामुळे या अहवालाला कोणताही आधार नाही. आधारची माहिती खूपच सुरक्षितपणे ठेवली जाते.

'संजय राऊत मूर्ख आहेत. प्रसिद्धीसाठी त्यांनी ही वक्तव्य केली आहेत. त्यातून त्यांना प्रसिद्धी मिळाली खरी, पण तुमच्या या कृत्यामुळं शिवसेनेची 'शव'सेना होईल. तुम्ही आधीही महापालिका निवडणुका हरलात. आताही तुम्हाला धडा मिळालाय. उद्या तुमचं नामोनिशाण राहणार नाही,' असा घणाघात मुनींनी केला आहे. 'संजय राऊताना वाटतं मुंबई आमची आहे. कोण म्हणतं मुंबई तुमची आहे? कोण ओळखतं संजय राऊत यांना? ही मुंबई संत गोरा कुंभाराची, नामदेवाची, ज्ञानेश्वरांची, तुकारामांची, छत्रपती शिवाजी महाराजांची आणि संभाजी राजांची आहे. तुमची नाही,' असं सूर्यसागर यांनी सुनावलं आहे.
